The covered sporting activities are: gym activities, athletics, cycle touring, curling, hot-air balloon excursions, hiking, jogging, ball games, beach games and camping activities, kayaking, swimming, orienteering, paddle surfing, fishing, snowshoeing, segway, hiking, snorkelling, trekking below an altitude of 2,000 metres and any other activity of similar characteristics.

Activities carried out at altitudes of more than 5,000 metres, all aerial sports, as well as underwater activities involving immersion at depths of more than 30 metres are expressly excluded.

Under no circumstances shall participation in official or private sporting competitions, training, trials or bets be covered. For the purposes of this policy, "competition" shall always be understood to mean any occasion on which the sporting activity is carried out within the framework of an act or event organised by a third party other than the POLICYHOLDER and/or the INSURED.
